Fines and Fees Ordinance

Ordinance No. 20240325-1

Oglesby Public Library District

WHEREAS, the Public Library District Act of 1991, 75 ILCS 16 30-55.70 stipulates that a board may provide, by ordinance, fines and penalties (i) for injury to any book or other library material or to any real or person property belonging to or in the custody of the library and (ii) for failure to return any book or other material or personal property belonging to or in the custody of the library.

NOW, THEREFORE, BE IT ORDAINED that the Board of Trustees of the Oglesby Public Library District adopt the following fines and penalties: The library remains a fine free library and does not charge fines for collection items borrowed

from the Oglesby Public Library District and returned without damage beyond repair since March 21, 2022. BE IT FURTHER ORDAINED that the library establishes the following replacement fees for

A fee equal to the price of the lost or damaged material beyond repair (exclusive of periodicals) plus a \$10 processing fee

Periodicals-A replacement fee of \$6.00 per issue.

materials lost or damaged beyond repair:

BE IT FURTHER ORDAINED patrons with responsibility for material in any format are also responsible for all collection and/or court costs incurred by the library in its efforts to secure the return of the material.

BE IT FUTHER ORDAINED, that the library provides copying, faxing, and notary public services to the community with the following fees for services as of July 1, 2023:
